1	The total number of section of the school shall be restricted to 28 as per the running number of sections and available land and infrastructure. Further the increase of any section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by laws and subject to the availability of room size of greater than 500 sq ft.
2	The library is seen as under stocked and with insufficient seating arrangements. Seating arrangement is not sufficient as per the running sections. 5	Computer Science Lab and the Library seems to be in the sharing hall. The computer Science Lab be shifted in another nearby hall of proepr size with more number of computers and enhanced seating arrangements. Compliance be made on SARAS within 03 months.
6	School shall ensure the fixing of permanent signage at toilets and all other prominent places.
7	School shall ensure the training of teachers from CoE, Pune within 03 months and to upload the compliance within 03 months
8	The school should apply for change in land area in OASIS on SARAS portal on the basis of documents shown to the RC.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
